

October 31, 2022 To: Mayor Torre and Aspen City Council Re: 2022 Galena Cooper Living Lab

The Aspen Chamber Resort Association and the business community is in line with council's goal to increase safety, ease, and intuitiveness for all users, including pedestrians, bicycles, and vehicles downtown. We appreciate the opportunity to be a partner in outreach and education to our 750 local business members. The ACRA Board of Directors and Public Affairs committee has participated in focus groups and check ins regarding safety in the downtown core and the summer 2022 Galena Living Lab, the full summary of our outreach is attached.

To fully represent our members regarding safety in the downtown core, we have used our newsletter and social media accounts to share outreach opportunities provided by the city. We have also set up a resource page on <u>aspenchamber.org</u> that includes a history of the project, news coverage, and links to Aspen Community Voice outreach opportunities.

Along with convening multiple focus groups over the last year, we further solicited feedback from the business community through an open-ended comment form, a poll distributed through the webpage and newsletters, and an in-person feedback forum hosted on October 13<sup>th</sup>, 2022.

As you consider the future of the Galena corridor and any permanent modifications, we ask you to give credence to the community members who have shared their perspectives and concluded that this summer's modifications do not feel like a safe solution. You have already made steps in line with community wishes by removing the counterflow bike lane and returning one side of the street to angled parking, and we thank you for those revisions.

We respectfully ask that Hyman Avenue be returned to two-way traffic, presented as "Option One" in your packet. This street serves as a vital way out of the busy Galena/Cooper corner. This is needed not only for those who find themselves headed south on the 200 block of Galena, but also for the daily occurrence of those who unwittingly find themselves going the wrong direction on Cooper into Galena, as is frequently observed by our guest services staff at the visitor information booth on the Paradise corner. Furthermore as your data shows, an average of 1.93 cars every 30 mins - or nearly 4 an hour - turn left at the Galena/Hyman intersection and go the wrong way down Hyman, significantly increasing danger in this high use area.

You will see in the attached charts that more than 60% of survey respondents request that Hyman Ave. return to two-way traffic, and this was a frequent comment in our intersection-by-intersection station at our open house.

Secondly, we ask that you allow for open public comment and community discussion before directing that there be permanent changes or future labs downtown. As you have heard, the top message we received from our membership was that they did not feel their input or participation mattered before or during this experiment.

We understand that feedback was collected through public surveys and the hotline, but the absence of opportunity for public comment in any council discussions on the topic has created an incomplete engagement environment. While council has access to the full variety of comments that have ended up in your inbox, individuals are not privy to the varying perspectives of their fellow community members, and unable to share their thoughts constructively in a public manner.

Again, ACRA and the business community appreciate the need for creative solutions to improve safety for all those who travel to and through our downtown core. We thank you for addressing this need, and look forward to further opportunities to facilitate community-oriented solutions for all.
